

## **Intel Gaming Access Sweepstakes 3.19**

### **ONLINE GIVEAWAY RULES**

#### **1. Eligibility**

The Intel Gaming Access – Dark Crystals Sweepstakes (“Sweepstakes”) is open only to legal residents of the United States or Canada (excluding Quebec) who have reached the age of majority in their state of residence at the time of entry and are members of the Intel Gaming Access Program.
